DLP 2050 Redispersible Latex Powder has especially been developed for Self Leveling Flooring Compounds and Repair Mortars based on cement. DLP 2050 product has a very low VOC, which makes the product suitable to produce Self Leveling Flooring Compounds meeting the EMICODE EC1 requirements.

It offers enhanced surface quality, adhesion to the substrate

and helps to reduce the formation of cracks caused by shrinkage.

#### **Handling**

DOW<sup>TM</sup> Latex Powder (DLP) 2050 Redispersible Latex Powder is a free-flowing powder, and as such can create dust. Avoid dust build-up. Fine dust of this product can form explosive mixtures with air and could pose fire and explosion hazard; keep away from ignition sources. Take precautions to avoid accumulation of static charge. Practice care and caution to avoid explosive conditions.

#### **Storage**

DLP 2050 Redispersible Latex Powder should be stored in a dry and cool environment. Storage in high humidity and temperature will increase the risk of blocking. Storage under pressure should also be avoided. Do not stack pallets on top of each other. Please consult the SDS for information on the product shelf life.

#### **Disposal**

Typically, DLP 2050 Redispersible Latex Powder products can be disposed of by industrial incineration or in an approved landfill, providing regulations are observed.
